The photographers have the ability to upload photos directly to listings on behalf of brokers.

### Limit Hassle

Many Photographers offer a variety of services including drone/aerial footage, virtual tours, photography services, making marketing the property easier.

### Right to Retain Photography

Photographers agree to a non-exclusive, unlimited license. That's a long way of saying in most circumstances, the MLS can retain the photos in the database free of copyright infringement forever.

Photographers complete a Mid Georgia MLS provided training course for uploading photos directly to listing.

After the photographers have completed the steps above, they are added to the Certified Photographer Program.

### For Photographers

Q: How do I become a member of the Certified Photographer Program?

A: Apply at <u>www.midgamls.com</u>. We will review the application, and if you and the studio are a good fit, you will be invited to join.

Q: What are the requirements beyond the application?

A: Once adequately vetted, you will be asked to sign an agreement between Mid Georgia MLS and Photographer/Studio. Next, you must take an online training course for uploading photos into the MLS database. Lastly, once these items are completed, you will be added to the list.

Q: What are the benefits of becoming a Certified Photographer?

**A:** You'll get connected. More than 800 real estate professionals can access our Certified Photographer Program list within our private database. Building a professional relationship of loyalty and trust benefits both the Broker and the Photographer. We will recognize you on our public-facing website, www.midgamls.com.

Q: What is the cost of joining the Certified Photographer Program?

A: At this time, none!

### For Brokers

Q: Who owns your property photos?

A: It depends on the agreement you enter with the photographer. To assist you with a basic understanding of Photography License Agreements. Here are the three most common types:

Work for Hire: This agreement provides that the commissioned photographs are a "Work for Hire," which means the commissioning party is the automatic owner of the photographs from their creation.

Assignment Agreement: In this agreement, the photographer assigns the broker all rights, title, and interest in the photographs. The photographer grants the broker all rights necessary to transfer or license the copyright/intellectual property of the images to MLS or anyone else to whom the broker may transfer the license.

Exclusive License Agreement: A photographer may want to retain ownership of the photographs. In this agreement, the photographer grants the broker an exclusive license to display and distribute the photographs in connection with the real estate industry specific to the property. At the same time, it is listed as active for a specified period.

It is crucial to know what rights you own in photographs and how those rights permit you to use the photographs. To reduce your risk of copyright infringement, you should:

- · Review photography agreements to assess what rights were granted or conveyed.
- · Audit your use of listing photographs to ensure compliance with the relevant agreements.
- · Determine how you will use photographs and ensure future agreements permit those uses.
- · Maintain records of all assignments and licenses with your important legal documents.

### For Brokers Continued

**Q:** If I use a photographer from the Certified Photographer Program (CPP), do I have the right to use the photographs in the MLS in advertising within the real estate industry?

**A:** Yes. While the property is being marketed, the photographs may be used in connection with the real estate industry when listed as an active property for sale. Beyond that, it depends on the agreement you enter with the photographer. The Certified Photographer Program (CPP) does not give you unlimited use. It allows the MLS to retain the photos in the MLS. All photographers participating in the CPP sign an agreement giving the MLS rights to maintain their photography in the MLS.

**Q:** Am I protected from copyright infringement if reproducing, displaying, printing, broadcasting, and licensing the images covered by the CPP?

**A:** Yes. You are protected using the photography while the property is for sale. After the property is sold, you ARE NOT safeguarded and do not have a right to reproduce or display the photos since it will depend on your individual agreements with the photographer. The MLS may retain them for viewing in the database.

Q: Can the Certified Photographer upload photos to listings on my behalf?

A: YES. All members of the Certified Photographer Program (CPP) complete a training course for uploading photos to listings via Flexmls. However, it is up to the brokerage if they want the photographer to upload the photos. You make that decision, not the MLS.

### For Brokers Continued

Q: Can the photographer change the listing other than upload photos?

A: NO. The photographers are assigned a user number for the sole purpose of uploading photos to a specific listing in the MLS database.

Q: My photographer is not currently part of the Certified Photographer Program; can they be added?

A: YES. Simply refer them to our website: www.midgamls.com.
